KidzWorxx™ Independent Creativity Specialists Agreement General Terms and Conditions

A. As an Independent Sales Consultant for KidzWorxx I Agree:

1. To maintain the highest standards of integrity, honesty and responsibility in dealings with the Company, consumers and other KidzWorxx™ Specialists. To present KidzWorxx™ products in a truthful and sincere manner and hold the Company harmless from damages resulting from misrepresentations by me.
2. To assume sole liability for all self-employment (Social Security), income taxes, sales tax and other reports required by my activities as an Creativity Specialist and to abide by all federal, state and local laws governing my KidzWorxx™ business.
3. I am not a joint venturer with, nor franchisee, partner, agent or employee of the Company. I have no power or authority to incur any debt, obligation or liability on behalf of the Company. I understand that all Creativity Specialists (including myself) are independent contractors and are subject to this provision.
4. The Company reserves the right to assure continued service/sales to my customers through other active Creativity Specialists if I cease to be an active KidzWorxx™ Creativity Specialist.
5. The Company may release my name and telephone number in response to a customer's request for a KidzWorxx™ Creativity Specialist in my area. If this information should not be released, I agree to notify Company that I do not want this information released by written notice directed to: KidzWorxx™, 1300 Norplex Drive, LaCrosse, WI 54601.
6. To comply with any changes to the General Terms and Conditions of the Creativity Specialists Agreement that may be made by the Company.

B. KidzWorxx™ ("Company") Agrees:

1. The Company may change suggested retail prices at any time. Company will give the Creativity Specialist at least (10) ten days prior written notice.
2. No geographical territories or limits concerning sales or recruiting within the United States are imposed on a KidzWorxx™ Creativity Specialist.
3. The Company reserves no right of control or direction of Creativity Specialist's activities only as it pertains to the above agreed terms and results thereof.

This is the sole and only Agreement between the parties relating to the subject matter hereof, and both parties acknowledge that the Creativity Specialist is not an employee of the Company and will not be treated as an employee with respect to this Agreement for federal, state or local tax purposes, or otherwise.

This Agreement shall be effective from the date of acceptance until December 31 of the same year and shall thereafter be automatically renewed each January 1, for additional terms of one year each, provided that the Agreement may be terminated by either party effective immediately for any breach of its provisions or by either party at any time during the initial term or any renewal term by not less than thirty (30) days written notice.
